(A State University established by Govt. of Haryana Act No. 25 of 2014)

Revised Qualifications for the post of Principal and Assistant Professor in Self-Financing B.Ed. Colleges as per NCTE norms as per Amendment of 29 May, 2017.

A. Principal

- Post-graduate degree in Arts/Sciences/Social Sciences/Humanities/Commerce with minimum 55% marks, and
- ii. M.Ed. with minimum 55% marks; and

Or

*M.A. in Education and B.Ed. with 55% marks in each; and

- iii. Ph.D. in Education or in any pedagogic subject offered in the institution; and
- iv. Eight years of teaching experience in a Secondary Teacher Education Institution after eligibility.

B. Assistant Professor (Perspectives in Education or Foundation Courses)

- i. Post-Graduate degree in Social Sciences with minimum 55% marks; and
- ii. M.Ed. degree from a recognised university with minimum 55 % marks.

Or

- i. Post-Graduate (MA) degree in Education with minimum 55% marks; and
- ii. B.Ed./B.El.Ed. degree with minimum 55% marks.

C. Assistant Professor in Curriculum and Pedagogic Courses

- Post-Graduate degree in Social Sciences/Sciences/Mathematics/ Languages with minimum 55% marks; and
- M.Ed. degree with minimum 55% marks.

(Note: In case of B and C put together, for two faculty positions, a postgraduate degree in Sociology/Psychology/Philosophy with 55% marks, and B.Ed./B. El. Edu. with 55% marks and three years of teaching experience in a secondary school shall be considered).

Note: - "Besides fulfilling the above qualifications, the candidate shall have cleared the National Eligibility Test (NET) conducted by University Grants Commission. Provided candidates who are, or have been awarded Ph.D. degree in Education in accordance with the UGC (Minimum Standard and Procedure for Award of Ph.D. Degree) Regulations 2009, shall be exempted for the requirement of the clearing of NET for appointment as Assistant Professor or equivalent position in Universities or colleges or institutions".

D. Assistant Professor in Education (Fine Arts/Performing Arts)

Visual Arts

Post-graduate degree in Fine Arts (MFA) with minimum 55% marks.

Performing Arts

i. Post-graduate degree in Music/Dance/Theatre Arts with minimum 55% marks

E. Assistant Professor in Physical Education

 Master of Physical Education (M.P.Ed.) with minimum 55% marks. (Training/qualification in yoga education shall be desirable)

"* The Executive Council has allowed to incorporate in the qualifications of the Principal that M.A. in Education and B.Ed. with 55% marks will also be eligible for the post of Principal in SFS Colleges of Education vide Resolution No. 09 of the 37th meeting held on 05.12.2023 on the analogy of MDU, Rohtak."

Note: -

- 1. Master's degree in the subjects of Physics/Chemistry/Biochemistry/Electronic Sciences or any other relevant subject will be required for appointment to the post of Assistant Professor in Education for Teaching of Physical Science.
- Master's degree in the subjects of Zoology/Botany/Environmental Science/ Microbiology/Plant Physiology/Biotechnology or any other relevant subject will be required for appointment to the post of Lecturer in Education for Teaching of Life Science.
- Master's degree in the subjects of History/Political Science/Economics/ Geography/Sociology/Public Administration or any other relevant subject, will be required for appointment to the post of Assistant Professor in Education for Teaching of Social Studies.

Important Instructions: -

- A relaxation of 5% marks from 55% to 50% shall be provided at the M.Ed./M.A. Education level for SC/ST/Physically/Visually Handicapped Category for the post of Principal and Assistant Professors. B in the 7-point scale with letter grade 0, A, B, C, D and F shall be regarded as equivalent to 55% wherever the grading system is followed.
- 2. All the vacancies will be advertised in two national newspapers (one each in English and Hindi) having wide circulation, specifying the required qualifications i.e. NET/SLET/Ph.D. in Education or in the relevant School subject and specialization etc. The College/Institute shall request the office of the Dean, College, CBLU, Bhiwani for fixation of interview and constitution of Selection Committee within 7 days of the advertisement.
- 3. The College/Institute will submit the synopsis of applicants immediately after the last date of the receipt of applications through e-mail/speed- post/Fax.
- 4. All the applicants shall endorse a copy of the application to the Dean, College, CBLU, Bhiwani.
- 5. The appointments should be made on the basis of merit through interview by the prescribed Selection Committee. Priority should always be given to NET ISLET /SET /Ph.D. Candidates.
- 6. The Academic approval will be granted to only those selected Principals/Teachers who fulfill the requisite qualifications at the time of selection.
- 7. Reservation: The reservation for Scheduled Castes/Scheduled Tribes/Other Backward Castes/differently abled persons and other categories shall be as per the extant policy of the Central Govt. or State Govt. or as applicable to all other categories of Service in Government.
